

AGREEMENT FOR USE OF BICYCLE, RELEASE AND WAIVER OF LIABILITY

PLEASE READ CAREFULLY BEFORE SIGNING:

SECTION I: RELEASE: Renter/Participant agrees that this AGREEMENT FOR USE OF BICYCLE AND RELEASE AND WAIVER OF LIABILITY is governed by, and intended to be as broad and inclusive as permitted by the laws of Pennsylvania and that the jurisdiction for any claims is only in The Courts of Common Pleas of Allegheny County, Pennsylvania. By signing this form, I am acknowledging that I am physically and mentally able to ride a bicycle and I am familiar with riding a bicycle and the risks involved with this activity. I expressly assume all risk of loss, damage or injury as a result of participating in usage, and/or riding, including the risk due to Pittsburgh Bike Rentals Inc (D/B/A Golden Triangle Bike Rental and here after referred to as GTBR) negligence. I agree to fully release and discharge GTBR for any damages, injuries or claims, including but not limited to myself or any other person or property, as a result of my use of the bicycle. I fully understand and agree to release GTBR for its negligence in causing whole or in part any injury to me.

SECTION II: EQUIPMENT RENTAL: Participants assume full responsibility for the bicycle and any other equipment rented or included in the rental. Participants agree to compensate GTBR, for damages and/or theft of equipment during rental period unless insurance is purchased (see below). GTBR is not responsible for participants who incur equipment malfunction (i.e., flat tire) during the rental period. Upon request, extra bike tubes and tools can be provided to participants for use with the rental equipment. GTBR will do its best to resolve any malfunctions, but this service is not guaranteed. Participant agrees that bike and equipment are in undamaged, working and in good condition at the time of rental.

SECTION III: REPRESENTATIONS AND SIGNATURES: Each Participant freely and voluntarily assumes the risks of using the equipment and/or participating in a tour. Each Participant acknowledges that he/she has executed this AGREEMENT FOR USE OF BICYCLE AND RELEASE AND WAIVER OF LIABILITY in order to use the Equipment and/or participate in a tour. For each participant who is a minor, the adult participant signing on his/her behalf represents and warrants to GTBR that he/she is the legal guardian of that minor and possesses full legal authority to release and waive claims, and to covenant not to sue on that minor's behalf. By signing this form I am acknowledging that I am at least 18 years of age. By signing for a minor, I am agreeing that I am their parent or legal guardian and am releasing GTBR from any claims, lawsuits or responsibilities for that minor. Each of the undersigned has read this AGREEMENT FOR USE OF BICYCLE AND RELEASE AND WAIVER OF LIABILITY.

SECTION IV: HELMETS: Helmets are REQUIRED for multi-day trips on the GAP/C&O. Rider agrees to wear a helmet. GTBR provides a helmet, free of charge, for riders who do not bring their own.

SECTION V: PARTICIPANT AGREES TO GTBR's TERMS AND CONDITIONS (available upon request)

SECTION VI: INSURANCE A detailed list of replacement costs are available upon request. Rider is not responsible for normal wear and tear.

YES! I'd like to purchase bike/equipment insurance for \$15: Insurance covers 75% of the replacement cost of any unrepairable, damaged, missing or broken parts, equipment and/or bikes. Rider is responsible for 25%. In the event of theft, a police report must be filed, and a copy must be presented to GTBR for this policy to be valid.
